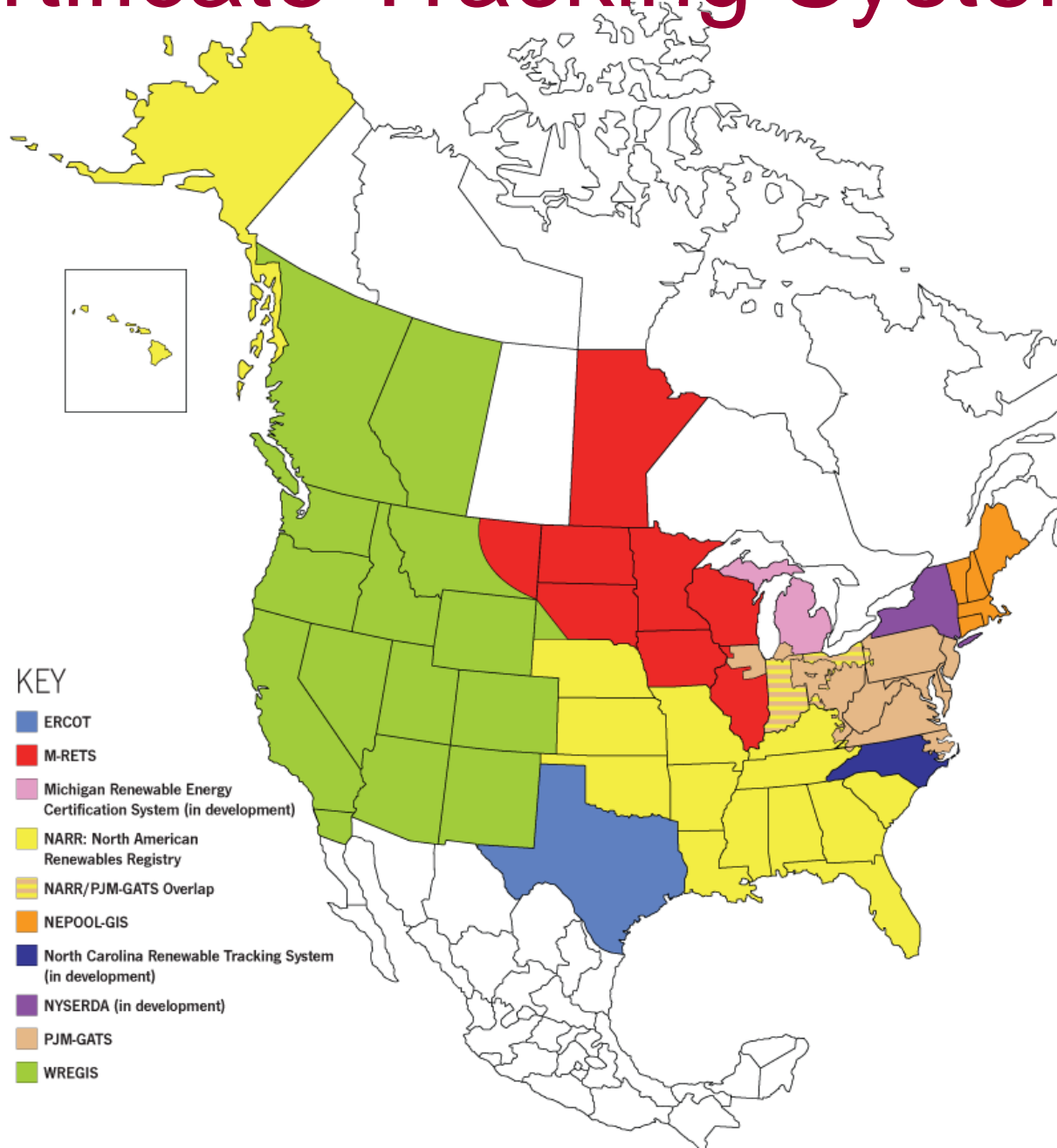

Certificate Tracking Systems



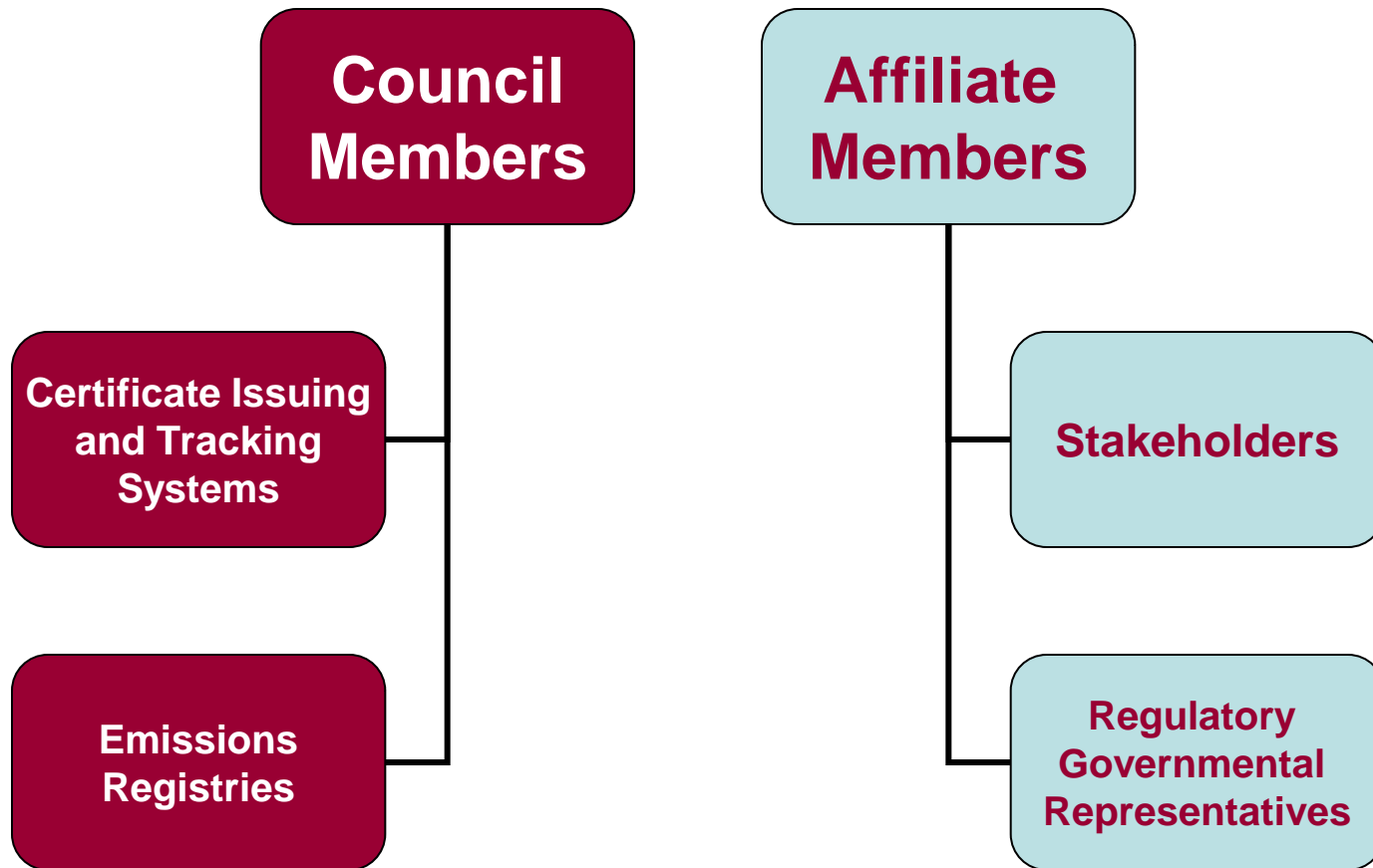
